LexisNexis and Westlaw

Both Lexis and Westlaw have tabs devoted exclusively to news coverage, both foreign and domestic. Be sure to check both databases because some titles do not appear in both. For example, the New York Times is available in full text only on Westlaw, while the Wall Street Journal is only available on LexisNexis.

Both Westlaw and LexisNexis have services that automatically alert you to news articles on your topic. Setting up an alert is easy:

Westlaw West Clip

1. Click on "Alert Center" in the upper right corner of Westlaw.
2. Choose "Create" under West Clip
Name your clip. This is the email subject line that is emailed to your account.
3. Choose database(s) to search.
ALLNEWS is the database for searching news available on Westlaw. Specific sources will have their own database name such as NYT (New York Times) or CHICAGOTR (Chicago Tribune). There is a link to a database wizard to help you find databases.
4. Choose search terms.

5. Click finish.

LexisNexis Alerts

Any search run on Lexis can then be "Saved as an Alert." Clicking on this link pulls up email options. You can manage your alerts via the Alerts tab.
