### Why use print?

#### Easy to read

West’s National Reporter System uses an easy-to-read two-column format.

#### Easy to use

Electronic research can be frustrating. With reporters, there are no timed-out searches, forgotten passwords, or printing woes.

#### Available to the public

Only CSLL faculty, students, and members can use Westlaw and LexisNexis. The reporters in the library are available to the public.
